### Guest Policies

- Payment and Cancellation Policies
  - There is a one-day cancellation policy and a \$20 per-person charge if you cancel within one day of the reservation or are a "no show" for the reservation. A credit card is required at the time of booking as a guaranty.

  - Payment or credit card guaranty is required at the time of booking.
  - If applicable, a gratuity of 18% will be automatically added for parties of 6 or more.
- Directions and Transportation Tips
  - Transportation Time: Allow up to 1.5 hours to travel to your destination when traveling within **Walt Disney World** property.
- Dietary Policies
  - Most Walt Disney World Resort table-service restaurants that accept advance reservations can accommodate Kosher needs if requested at least 24 hours in advance by calling (407) WDW-DINE or (407) 939-3463. Guests under age 18 must have parent or guardian permission to call. A credit card is required to guarantee this meal; the full price of ordered meals will be charged if you cancel within one day of the reservation or are a "no show" for the reservation. At family-style or buffet locations, you will only receive one meal; does not include all-you-care-to-eat. You will be charged the regular buffet or all-you-care-to-eat price.

- All Walt Disney World Resort table-service restaurants that accept reservations offer balanced menu choices and can accommodate lifestyle dining options (such as no sugar added, low-fat, low-sodium, vegetarian or vegan). Please advise a Cast Member of your request at the time you place your order and he or she will be happy to assist. For dinner shows, 24-hour notice is required for any lifestyle menu request. Our quick-service locations also offer balanced menu choices and can accommodate most lifestyle dining options.
- All Walt Disney World Resort table service restaurants that accept reservations may accommodate special dietary requests (such as allergies to gluten or wheat, shellfish, soy, lactose or milk, peanuts, tree nuts, fish, or eggs) if requested in advance. Please contact [specialdiets@disneyworld.com](mailto:specialdiets@disneyworld.com) at least 2 weeks prior to your table-service reservation or quick-service dining experience. Calls outside of business hours will be returned the next business day. You may also ask to speak to a chef upon arrival at the restaurant.
- This dining facility can accommodate most special dietary needs. Advance notice may be required and cancellation fees may apply. Please indicate any special dietary need at time of reservation booking.
- General Information

- Due to capacity constraints as well as the numerous private functions hosted by the California Grill, only patrons of the California Grill may use the 15th floor observation deck at Disney's Contemporary Resort.

Guests who have dined prior in the evening may return to California Grill to view the fireworks. Guests will need to present their receipt from dinner to gain re-entry to the restaurant.

As an alternative, Disney Resort Guests who are visiting Disney's Contemporary Resort for shopping or dining experiences may visit a fireworks viewing location on the north end of the 4th floor Grand Canyon Concourse. Proceed past the Concourse Sundries and Spirits shop and exit the doors to the exterior. From the viewing area, Guests can see Cinderella Castle and **Magic Kingdom**® theme park, and hear the background music and sounds synchronized with the Wishes fireworks display. There is a small area under cover for viewing during inclement weather.

- California Grill check-in for Guests with reservations or those wishing to enjoy the lounge: Check-in at a podium located on the 2nd floor of Disney's Contemporary Resort. Guests will be escorted by a Cast Member up to the 15th floor restaurant in an elevator exclusively reserved for California Grill diners.
- Dress Code Guidelines:

**Men:** Khakis, slacks, jeans, dress shorts, collared shirts. Sport coats are optional.

**Ladies:** Capris, skirts, dresses, jeans, dress shorts.

**NOT permitted in dining room:** Tank tops, swimwear, hats for gentleman, cut offs or torn clothing. While t-shirts are now allowed, the policy remains that t-shirts with offensive language and/or graphics are **NOT** acceptable.

- The sushi and Chef's counter are seated on a first-come, first-served basis.
- Special seating requests, such as by the window or outside, must be made at the dining facility.
- The sushi and Chef's counter are seated on a first-come, first-served basis.
- Menu items, pricing and hours are subject to change without notice.
- No outside wines are allowed to be brought into the restaurant. The California Grill offers a progressive wine program featuring the best of California wines, all served by the bottle or by the glass.
- Specialty celebration cakes are available for an additional charge and should be ordered 48 hours in advance by calling the Cake Hotline at (407) 827-2253. Guests under age 18 must have parent or guardian permission to call.
- Guests may request a 6" cake (non-personalized) upon arrival at the dining location for a charge of \$21.00 plus tax and gratuity (no advance notice required), with the exception of Victoria & Albert's at Disney's Grand Floridian Resort & Spa. Guests who wish to order a personalized cake may call the "Cake Hotline" at (407) 827-2253. Guests under age 18 must have parent or guardian permission to call. Personalized cake orders require 48-hour advance notice.
- All Walt Disney World dining facilities are non-smoking.
- Guests under the age of 3 may share from an adult plate at no charge or may purchase a meal from the menu.
